

# SUZUKI CHARTER SCHOOL RE-ENTRY PLAN 2020/21

revised July 31, 2020

## **OVERVIEW**

Following the government announcement on July 22, beginning September 1, 2020, all Alberta school jurisdictions were directed to implement Scenario 1 (In School Classes Resume) based on the advice of the ministry and the Chief Medical Officer of Health (MOH) with the understanding that this directive could change as pandemic conditions change. We are looking forward to welcoming our students and staff back.

Key changes to the revised School Re-Entry Plan include:

- 1. <u>At-home learning</u> will be provided to accommodate students who are unable to attend due to serious medical concerns.
- 2. <u>Masks</u>. Students and staff are free to wear masks at any time but need to have one for instances when teachers deem it desirable for them to wear them for example when they are transitioning. (The MOH is currently reviewing the research and evidence around the effectiveness of mask use to mitigate risk for students. This information will help inform any needed revisions to our procedures.)
- 3. <u>Required school supplies</u> will include face coverings, water bottle, and earbuds/headphones (with attached microphone if possible). Fountains are equipped with water bottle filling functionality.
- 4. <u>School access</u> protocols.
- 5. Emergency procedures are currently being developed by the MOH and will be added to our plan when they are shared.

We want you to be confident that we are taking pandemic risks very seriously and that the health of students and staff is paramount. Following the Premier's announcement, we reviewed our plans for school re-entry and adjusted them to ensure that we are meeting or surpassing recommendations and that health measures, procedures and materials will be ready for the fall. <u>We can't stress enough that the cooperation of our community of parents is essential for the health and safety of our students and staff as outlined in our school re-entry plans.</u> Please read the key expectations and more detailed plans attached.

We welcome your feedback, deeply care about the welfare of our students, staff, and families and will be continuing to work with staff to support our plan for school re-entry. Contact Principal Karen Spencer if you have any questions.

This document outlines the revised School Re-Entry Plan including the three scenarios presented by the government and includes the responsibilities of all stakeholders to reduce the risk of transmission of COVID-19.

## **KEY EXPECTATIONS** TO REDUCE THE RISK OF COVID-19 TRANSMISSION:

- 1. Parents will screen students daily before school using the <u>Pre-Screening COVID-19 Checklist</u>, and keep students home if symptomatic. Parents will pick up students if they develop symptoms during the day.
- 2. Parents will not be allowed into the school resulting in adjustments in <u>Morning Drop Off</u> <u>Procedures</u> and <u>After School Dismissal Procedures</u> including outside cohort drop-off and pick-up in designated zones. Arrangements can be made for interviews etc. by contacting the office. (Refer to the attached detailed Drop Off and Pick-Up information and maps.)
- 3. Students will practise hand hygiene upon entrance and exit to the school and classroom.
- 4. Staff will reorganize rooms to support physical distancing as much as possible.
- 5. Educational activities may be altered to meet regulations.
- 6. Large gatherings will be limited until health restrictions are removed including field trips, assemblies, and other school events.
- 7. Homeroom cohorts or groupings will be maintained as much as possible.
- 8. Foot traffic will be limited and guided within the school.
- 9. Communal resource sharing will be limited.
- 10. Cleaning and disinfecting will be enhanced.

# **PARENT EXPECTATIONS**

### PARENT EXPECTATIONS to support the health and safety of students and staff:

- Screen your child daily Use the <u>Pre-Screening COVID-19 Checklist</u> daily to determine if your child has any
  symptoms of COVID-19 and should not enter the building and/or attend school. Follow MOH guidelines or call 811 to
  determine the need for testing and/or self-isolation. Your child can return to school following MOH guidelines.
- **Self-Screen** In the event you have been scheduled by school personnel to enter the school, use the <u>Pre-Screening</u> <u>COVID-19 Checklist</u>, and do not enter if you have COVID-19 symptoms.
- **Provide individual supplies** Purchase and maintain individual stationary supplies, a water bottle, mask or gaiter, and earbuds with attached microphone if possible, to reduce communal sharing of resources.
- **Carefully review and follow our new morning and after school procedures and map** These procedures limit persons in the school and support physical distancing:
  - (1) Morning Drop-Off Procedure (SEE MAP):
    - Parents need to follow the attached map and take students to their designated drop-off zones between 8:10-8:30am.
    - Beginning at 8:10am, students may enter the school through their designated entrance and head straight to classrooms to be supervised by their teachers.
    - Parents need to clearly communicate plans for older sibling or alternative adult pick-ups with classroom teachers so arrangements can be made.
    - Parents of students registered in Morning Care can drop-off students at the front entrance or Capilano Street field entrance where they will be supervised outside in the field south of the school between 7:30-8:10am; they will be led to their designated entrance doors to go to their classrooms at 8:10am. Please note, there is a \$25/month fee for morning supervision between 7:30-8:10am. On cold and rainy days, students can bring their instruments inside.
    - On extremely stormy or cold days (-20°C or less) where the weather does not allow for safe outdoor play, students will be supervised in the gym and learning commons.
  - (2) <u>After School Dismissal and Pick-Up Procedure</u> (SEE MAP):
    - At 3:10pm, teachers will line up students and lead them outside to their designated pick-up zone and supervise until students are safely picked up. Arrangements should be made to ensure students are picked up before 3:30pm. Students registered for After School Care (ASC) will collect belongings and transition to their designated scheduled ASC cohort zone.
    - At 3:30pm, teachers will phone all parents who have not yet picked up students and will bring them to the front entrance to wait for pick-up.

## EMERGENCY PROCEDURES STUDENTS

### What happens if my child becomes symptomatic during the school day?

- 1. If a child becomes symptomatic the teacher will call home or emergency contacts to pick up the child as soon as possible, and parents will seek health advice from Alberta Health Services (AHS).
- 2. The child will be isolated as much as possible, either in a designated isolated space or in the classroom.
- 3. The student can return to school following MOH guidelines including screening, and testing if directed by AHS to identify and mitigate risk.

- 4. In the event that a student is diagnosed with COVID-19, AHS will direct and consult with the family and school to mitigate and manage risks within the community on a case-by-case basis.
- 5. No one directed home due to the onset of symptoms will be permitted to return until they confirm a negative COVID-19 test. (*The CMOH is working on an informative toolkit to address emergency procedures and protocols at this time.*)

If your child has a known, pre-existing condition that causes COVD-19 symptoms, they should be tested to confirm that COVID-19 is not the cause of the symptoms and to establish a "baseline" for staff.

Should two or more members of a cohort develop symptoms consistent with COVID-19, we will initiate the "outbreak notification procedure" that is to be provided by Alberta Health Services prior to the beginning of the school year.

# **MORNING DROP OFF PROCEDURES**

### 7:30-8:10am (Please note, there is a \$25/month fee for Morning Care Supervision.)


- K-3 Students Parents drop off students in the "Hug and Go" zone on 54 St. and students walk to the south field for Morning Care supervision where students will interact with grade level schoolmates <u>or</u> parents park and walk students to the south field.
- Gr.4-7 Students Parents drop off students in the "Hug and Go" zone on Capilano St. and students walk to the south field for Morning Care supervision <u>or</u> parents park and walk students to the south field.

#### 8:10-8:30am

- Beginning at 8:10am, *students only* may enter the school through their designated entrance and head straight to classrooms to be supervised by their teachers.
- K-3 and Gr.7 Students Parents drop off students in the "Hug and Go" zone on 54 St. and students walk to their designated entrances <u>or</u> parents park and walk students to their designated entrances. (SEE MAP)
- Gr.4-6 Students -Parents drop off students in the "Hug and Go" zone on Capilano St. and students walk to their designated entrances <u>or</u> parents park and walk students to their designated entrances. (SEE MAP)

#### After 8:30am

- Entrance doors will be locked at 8:30am. Ring the **INTERCOM** buzzer to the left of the doors and <u>students only</u> may enter.
- Parents can drop off students at the front entrance, *or* park and lead students to the front entrance.



# **AFTER SCHOOL DISMISSAL and PICK-UP PROCEDURES**

### 3:10-3:30pm

- K-3 and Gr.7 Students Teachers will line up students exit out their door, and lead them outside to their designated pick-up zone and supervise until students are safely picked up. (SEE MAP)
- Gr.4-6 Students Teachers will dismiss students to the west field for pick up on Capilano Street.
- Arrangements should be made to ensure students are picked up before 3:30pm.

### 3:30pm

 At 3:30pm, teachers will lead all students not picked up on time to the front entrance, and parents or emergency contacts will be phoned.
