- The Association of Alberta Public Charter Schools. (TAAPCS).
 Director James Garrison reported to the board with a summary of TAAPCS Priorities committee met twice in the last month.
 - Feb 25, 2021 meeting, items discussed
 - ➤ SLS funding, Assurance Model and Superintendent compensation. SLA funding with each change of government there seems to be a need to



- inform Alberta Education on the issues charter school face and the lack of equitable funding charter schools receive.
- ➤ SLS funding will be based on WMA and no board will receive less funding then in the 2020-2021 year.
- New schools for Calgary Arts Academy and the francophone school in Sherwood Park will new school built. Currently the francophone school is sharing space with New Horizons Charter School.
- March 16 th the committee was given a summary of the March 9, 2021 meeting held with Charter Schools from the southern part of the province and the Minister of Education. The Minister informed the boards a third party to be hired to review the students within charter schools and the student profiles in reference to SLS funding. Additionally, Alberta Education will be moving forward with evaluations of charters that have 15-year charters in their fourth and eighth years.
- Student Learning Supports Funding (SLS) for Charter Schools.
 Superintendent Paradis informed the board she has spoken to the Deputy Minister on several occasions in recent weeks regarding our request to change the SLS for Charter Schools.

Dr. Paradis has asked the Deputy Minister to please keep in mind when comparing a large district to a small district consideration needs to make for the cost of running a school/jurisdiction. Dr. Paradis added that choices for parents in education are in place however charter schools continue to have to fight for funding for our students.

Director Gish and Director Jen Garrison provided an update with their recent meeting with MLA Marlin Schmidt on March 1, 2021. MLA Schmidt was not aware of the differences in SLS funding between charter schools and traditional public school. Director Gish and Garrison explained the differences and provided MLA with some background information.
