A call for nominations from the floor at the AGM will complete the nomination process.

Elections for Board Director

Currently there are six (6) Directors all of whom have one year remaining in their term. In accordance with section 9(d) of the SCSS bylaws, the Board of Directors can have up to nine (9) directors. Therefore, three (3)-director position available for election. The election, if required, will be held during the AGM and successful incumbent shall hold office for three years or until resignation whichever occurs first.

At the *AGM a* ballot will be provided for all members *present* to elect up to three (3) Board Directors for the subsequent three years. Nominations may be taken from the floor as well. Ballots will be distributed to all members present and where_applicable, proxy ballots will be counted. Two members of the Society will join the Secretary Treasurer in counting ballots. Results will be presented to the AGM Chair and announced to the membership.
