5. Covid-19 Updates

The Superintendent provided latest updates from the government and led a discussion on the current Covid-19 pandemic with emphasis on the Omicron variant. A few factors were raised for consideration by the Board in the event schools had to go online or faced major setbacks to their ability to continue with in person classes. These included:

The possibility of establishing a staff backup list to be on standby in the event most teaching staff fell sick.

The possibility to transition some teaching staff to on-line instruction from home if needed. Putting parents on notice that students might have to be transitioned to on-line learning at very short notice.

Recommendation: The Board approves the changes (if any) to the covid risk management plan as presented.

There was no change to the school's current Risk Management plan.

6. SLS funding review update.

The Superintendent provided an update to The Board on the SLS funding review process. Comparator schools had been identified by Alberta Education to serve as the basis for comparison to Charter Schools to establish the fact that Charter Schools faced inequity in funding compared to Public and Catholic schools.

However, after review of the schools used as comparator it was identified that the comparisons were erroneous as Charter Schools are founded an a completely unique set of philosophies and comparing to a regular school will not result in a fair outcome.
